

**RE-ENROLLMENT  
THE PROUT SCHOOL  
2024-2025 SCHOOL YEAR ENROLLMENT CONTRACT**

I/we are hereby reserving a place for our son/daughter at THE PROUT SCHOOL for the 2024-2025 school year. I/we understand that our son/daughter is enrolled for the entire year and I/we are liable for all expenses incurred during that year.

I/we understand that our child's tuition for the year will be \$ 16,850 we understand that our current agreement with the FACTS Tuition Management Plan will be automatically rolled over into the 2024-2025 school year and that I/we will have the option of changing our current method of payment choosing from one of the following options:

- One (1) total payment (\$100.00 discount for paying in full) on June 10, 2024 (ACH withdrawal)
- Two (2) payment plan-June 10, 2024 and December 10, 2024 (ACH withdrawal)
- Ten (10) or Eleven (11) monthly payments commencing June 2025 (ACH withdrawal)

Completed student enrollment contracts along with a \$500.00 non-refundable tuition deposit should be returned to THE PROUT SCHOOL by March 8, 2024.

**Grade 12 Senior Graduation Fee:** \$250.00 includes college processing, cap and gown, graduation and yearbook.

Students whose accounts are in arrears at any time will not be permitted to attend classes. All accounts must be settled in order for Seniors to graduate.

Fundraising is necessary to fill the gap between tuition and actual per pupil costs. I/we agree to assist in the sale of tickets for THE PROUT SCHOOL raffle and will be responsible for the sale of 12 tickets for a total of \$240.00 (per family). I/we understand that \$240.00 will be added to our Tuition account in the event we do not meet this responsibility.

Any and all legal and other costs associated with the collection of unpaid tuition will be the responsibility of the parent or guardian. I/we understand that in the event of a withdrawal from THE PROUT SCHOOL, I/we will be responsible for paying tuition based on the following withdrawal dates:

- From beginning of school to September 30<sup>th</sup> – 25% of tuition due
- From October 1<sup>st</sup> to October 31<sup>st</sup> – 50% of tuition due
- From November 1<sup>st</sup> to January 31<sup>st</sup> – 75% of tuition due
- From February 1<sup>st</sup> until end of school year – 100% of tuition due

The Prout School does accept students with IEP's or 504 plans. The Prout School, as a private school, is not legally required to implement them nor does the school agree to alter and/or modify its curriculum to accommodate the specific needs of individual students. However, we do offer reasonable accommodations dependent on resources and personnel to assist students with learning differences and disabilities in their day to day classes. Please initial your acceptance of this limitation, if applicable to your child.
